17) 14 AMENDED (3) (4) ARTICLES OF INCORPORATION (3) OF 1 '51 ASIANCARE HEALTH SYSTEMS, INC. (2) (2) KNOW ALL MEN BY THESE PRESENTS:

The undersigned incorporators, of legal age, and majority of whom are residents of the Philippines, have this day voluntary agreed to form a stock corporation under the laws of the Republic of the Philippines;

THAT WE HEREBY CERTIFY:

FIRST: That the name of said corporation shall be:

ASIANCARE HEALTH SYSTEMS, INC.

SECOND: A. That the primary purpose of this corporation is:

PRIMARY PURPOSE

To establish, operate, maintain, adopt, develop, promote and engage in the business of providing medical, health maintenance and related services to the public, offering comprehensive health care delivery services and systems, thru the accreditation and integration of the services of hospitals, clinics, diagnostics centers and a pool of medical, surgical and health professionals duly qualified to practice by laws.

SECONDARY PURPOSES

- To invest in, own, hold or possess shares of stocks, equity, interest or participation, establish, maintain, operate, and/or manage clinics, laboratories, hospitals or medical facilities for the treatment, care and relief of sick, injured or otherwise infirm person, as may be necessary or incidental to carry on the business of the corporation in all its elements to develop, organize, sell and provide health maintenance programs, hospital services, equipment and supplies;
- To enter into, perform or carryout contracts of every nature and kind pertaining to the business
 of the Corporation and to enter into working arrangement with other corporations, firm or
 persons, within the limits prescribed by laws;
- To engage the services of such technicians, professionals, workers, employees or agents, and
 to purchase and acquire such properties, real or personal, goods, equipment and other
 commodities, as may be desired or be needed in the conduct or pursuit of the purposes of the
 corporation;
- 4. To borrow or raise money necessary to meet the financial requirements of the corporate business and in the pursuance of the same, to issue bonds, promissory notes and other evidences of indebtedness, and to secure the payment thereof by mortgage, piedge, deed of trust or lien upon the properties of the Corporation or to issue, pursuant to law, shares of capital stock, debentures and other evidences of indebtedness in payment for the properties acquired by the secure Corporation, or for money borrowed in the prosecution of its lawful business; Monitoring Department






